The tenure of the members shall be two years. The quorum for the meetings shall be 2 out of 3 members (including Chairman).

- a) The SAIP shall follow the principles of natural justice while deciding about the allegation of plagiarism against student, faculty, researcher, and staff of the University.
- b) The SAIP shall have the power to assess the levels of plagiarism and recommend penalty(ies) accordingly.
- c) The SAIP after investigation shall submit its report with the recommendation on penalties to be imposed to the IAIP within a period of 45 days from the date of receipt of complaint/initiation of the proceedings.
